Compendium of Good Practices in HIV response in the WHO European Region


Purpose: to document and disseminate successful interventions in alignment with the Action plan. The practices are examples of Member State's progress towards WHO/UNAIDS targets on prevention, treatment and care, AIDS-related deaths, discrimination, and financial sustainability from international to domestic funding.

Methodology: practices were gathered from December 2017-April 2018 (5 months), technically reviewed by WHO staff and a Selection Review Committee.

Launch: July 23 2018, high-level “Ministerial Policy Dialogue on HIV and related comorbidities in eastern Europe and central Asia”, hosted by WHO/Europe and the Government of the Netherlands in Amsterdam.



26 000 people died of TB



Every fifth **MDR-TB** on the Globe is in




Every **1** in **5** new TB

Political Milestones/frame


- **Moscow Declaration to End TB (November 2017)**

Process

In preparation of TB UNHLM:

January 2018, 142nd WHO Executive Board (EB), adopted **resolution in support of the TB UNHLM**, including a request to WHO to develop a draft TB multisectoral accountability framework for follow-up of UNHLM.



WHO stakeholder consultation on development of accountability framework, Geneva, 1-2 March, 2018



To be presented at 71st World Health Assembly (WHA), May 2018



(possible revisions)



Presentation at UNHLM, 26th September 2018
